Notice is hereby given that the local government of the Shire of Gnowangerup has prepared the above mentioned planning scheme amendment for the purpose of:

Rezoning Lot 3587 on Deposited Plan 121836 Gnowangerup-Tambellup Road and Lot 3913 on Deposited Plan 121838 Jordan Street, Pallinup from 'General Agriculture' to 'Rural Residential'.

Inserting Rural Residential Zone No. 3 (RR3) into Schedule 11 – Rural Residential Zone

Provisions and adding Special Conditions and Provisions to control subdivision and land use/ development.

Modifying Structure Plan Area No. 1 and correcting reference to Lot 35876 within Schedule 12 –Structure Plan Areas.

2016/17 COMMUNITY FINANCIAL ASSISTANCE GRANTS

Last year Council approved the reformed structure of our community grants, which now includes two grant categories:

1. **Quick Grants** - for applications up to \$500, primarily for volunteer support.
2. **Community Grants** - for applications from \$501-\$5,000 aimed at supporting community groups with small capital projects, events, projects etc.


Community Groups within the Shire are now invited to apply for Council assistance under either category for the 2016/2017 financial year. Comprehensive guidelines, application forms and acquittal statements for each category can be found on our website under the '*Quick Links*' section (right sidebar) or by navigating to <http://www.gnowangerup.wa.gov.au/our-council/public-documents/forms/>.

Requests for operational funding, works-in-kind or reimbursement for expenses prior to the 2016/17 financial year will no longer be accepted under the guidelines. Furthermore, this is now the only pathway to request Council contribution for partnership funding for any project throughout the year. Please then consider all events, projects or infrastructure your community group is planning for the 2016/17 year carefully, as applications will only be open once per year.

If your community group is interested in applying for assistance under either of the grant categories, please make contact with our Manager of Community Services, at cdo@gnowangerup.wa.gov.au) to discuss your idea. Our Community Development Officer will be available to assist with completing the application form and to answer any enquires you may have relating to the new format.

Applications are to be received no later than **4pm on Friday 6th May, 2016**. Please follow the guidelines in the application packs on how to submit your documentation. Applicants will be informed in writing of the outcome of their application, at the completion of the budget process.

PROPOSED LOCAL LAWS

Notice is given that the Shire of Gnowangerup proposes to make the following local laws:

Animals, Environment and Nuisance Local Law 2016;
Bush Fire Brigades Local Law 2016;
Dogs Local Law 2016;
Health Local Law 2016;
Local Government Property Local Law 2016;
Standing Orders Local Law 2016.

The purpose and effect of these local laws are as follows:

Animals, Environment and Nuisance Local Law 2016

Purpose:

To provide for the regulation, control and management of animals and the prevention of environmental damage and nuisances within the District.

Effect:

To establish the requirements with which any person keeping animals, or undertaking activities that have the potential to impact the environment or create nuisance must comply.

Bush Fire Brigades Local Law 2016

Purpose:

To make provisions about the organisation, establishment, maintenance and equipment of bush fire brigades.

Effect:

To align the local law with changes in law and operational practice.

Dogs Local Law 2016

Purpose:

To make provisions about the impounding of dogs, to control the number of dogs that can be kept on premises and the manner of keeping those dogs and to prescribe areas in which dogs are prohibited and dog exercise areas.

Effect:

To extend the controls over dogs which exist under the Dog Act 1976.

Health Local Law 2016

Purpose:

To provide a statutory means to effectively control issues that have the ability to adversely impact on the health and well being of the community.

Effect:

To allow health related issues to be sufficiently controlled so as to provide an acceptable standard for the maintenance of public health in the community.

Local Government Property Local Law 2016

Purpose:

To regulate the care, control and management of all property of the local government except thoroughfares.

Effect:

To control the use of local government property. Some activities are permitted only under a permit or under a determination and some activities are restricted or prohibited. Offences are created for inappropriate behaviour in or on local government property.

PROPOSED LOCAL LAWS

Standing Orders Local Law 2016

Purpose:

Is to provide the rules for the conduct of meetings of the Council, Committees and electors.

Effect:

To result in:

- the orderly and effective conduct of meetings;
- greater community understanding of the meeting process;
- better decision making by the Shire; and
- better outcomes from decisions made.
