NOTICE OF PROPOSED LOCAL LAW
SHIRE OF GNOWANGERUP DOGS LOCAL LAW 2024

The Shire of Gnowangerup resolved at the Ordinary Meeting of Council held on 25 September 2024 to make a local law relating to the Shire of Gnowangerup Dogs Local Law 2024.

The purpose of the Local Law is to make provisions about the impounding of dogs, to control the number of dogs that can be kept on premises and the manner of keeping those dogs and to prescribe areas in which dogs are prohibited and dog exercise areas.

The effect of the proposed Local Law is to extend the controls over dogs, which exist under the Dog Act 1976. The proposed local law may be inspected at or copies obtained from
